(a) Students have been submitted to the State Office on a Form 3 (Rule II, Sec. 2).

(b) A certified list of players, signed by Principal of each school, shall be exchanged five days before each contest (Rule III, Sec. 5).

3. Suspension or termination of its membership in this Association by either party to this contract shall render it null and void.

4. The school failing to carry out the provisions of this contract shall pay the other a forfeit of **\$350** Dollars, unless this contract is altered or cancelled by mutual agreement of the contracting schools (Rule IV, Sec. 3).

5. Only officials registered with the A.H.S.A.A. shall be used. The home school will be responsible for contracting with an A.H.S.A.A. sanctioned officials association.

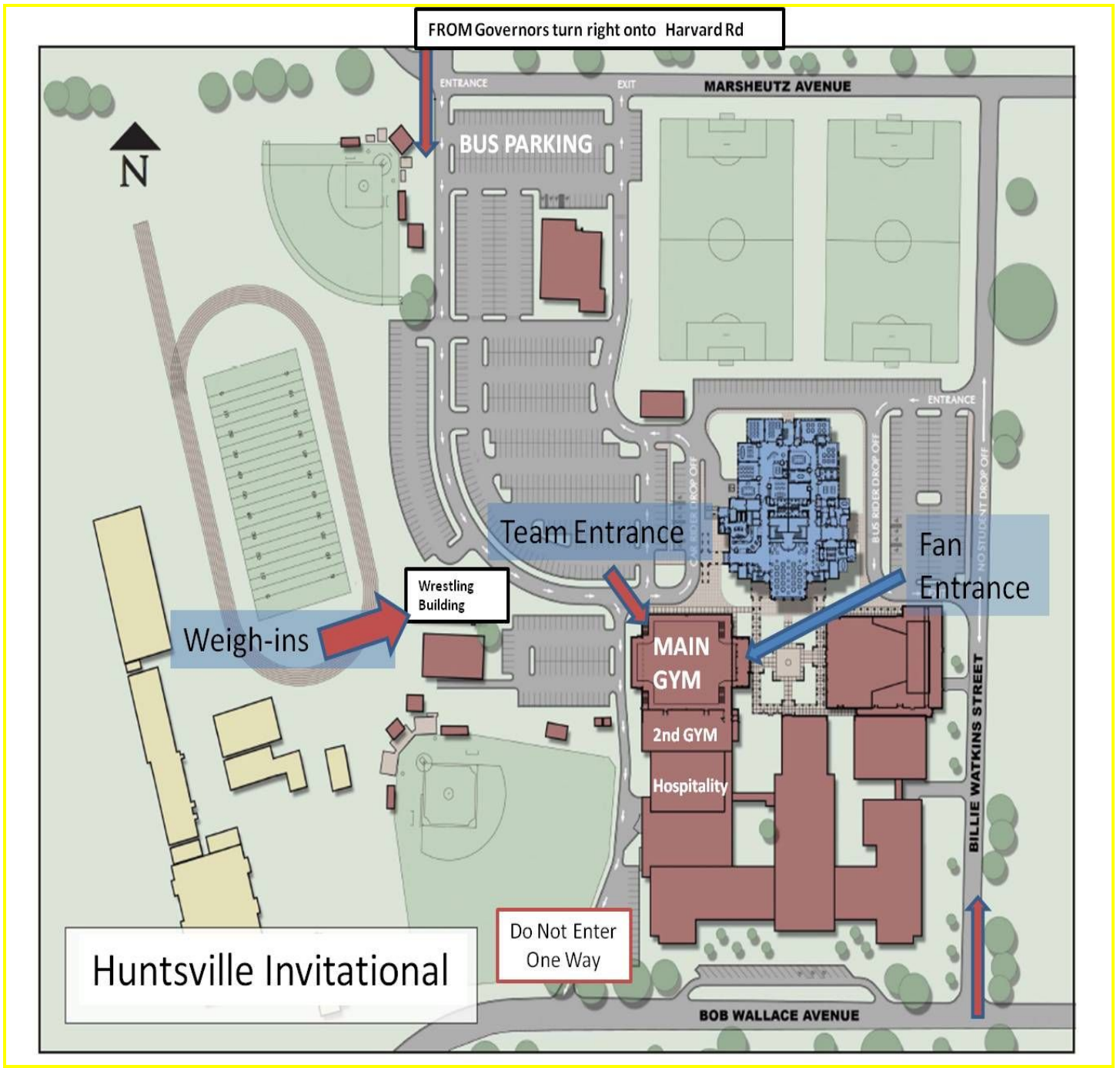
